Effective Date of Change to Type II

18A:9-9. Type II districts; effective date of change

If the voters of the district shall so elect that the district shall become a type II district, it shall thereafter be governed by the provisions of this title relating to type II districts, and the members of the board of education in office at the time of the election shall continue in office until the expiration of their respective terms and the qualification in office of their respective successors.

Effective date of change to Type II is upon certification of the election results: 11/20/2021

Term Impact of November Election

§ 18A:12-15.1. Terms of board members in certain districts

In the case of a school district in which the annual school election has been moved to November pursuant to subsection a. of section 1 of <u>P.L.2011, c.202</u> (<u>C.19:60-1.1</u>) or section 1 of <u>P.L.2012, c.78</u> (<u>C.19:60-1.2</u>), the term of office of a member of a board of education that is set to expire in April of a given year shall be extended until the day in January next following the year in which the term was originally set to expire when the member's successor takes office.

Electing Additional Board Members

§ 18A:9-10. Electing additional board members

If the membership of the board in any such district so becoming a type II district is less than nine, it shall be increased to nine by the election of added members at the next annual school election, unless the adopting election shall have been held more than 130 days or less than 60 days before the date fixed for such annual school election, in which case they shall be elected at a special school election which shall be called by the members of the board so holding over.

- Current Board Membership at time of 11/2/2021 General Election was 7. Since it is < 9, need + 2 more Board seats to = 9
- Default of when to add those 2 additional members is the next annual school election which would be 11/8/2022 unless the difference in time between 11/2/2021, the adopting election to move from Type I to Type II, and the next General Election (11/8/2022) is longer than 130 days, then the new members shall instead be elected at a Special School Election.



Timing of Election of New Members

§ 18A:9-10. Electing additional board members

If the membership of the board in any such district so becoming a type II district is less than nine, it shall be increased to nine by the election of added members at the next annual school election, unless the adopting election shall have been held more than 130 days or less than 60 days before the date fixed for such annual school election, in which case they shall be elected at a special school election which shall be called by the members of the board so holding over.

Special School Election Dates from State		
2 nd Tuesday in December	December 14, 2021	Need 60 days notice
4 th Tuesday in January	January 25, 2022	Need 60 days notice
2 nd Tuesday in March	March 8, 2022	Meets requirements
Last Tuesday in Sept	September 27, 2022	>130 days since adopting election
November General Election	November 8, 2022	>130 days since adopting election

Important Dates in 2022

1st School Board Election

Monday, January 17, 2022 at 4:00pm — Petition Filing deadline for School Board. There will be two seats available for candidates to run for: both seats are for a term of one year and eight months each.

Tuesday, March 1, 2022 — Last Day to request a Vote by Mail Ballot via mail.

Monday, March 7, 2022 at 3:00pm — Last day to apply for Vote by Mail Ballot in person or by an authorized messenger.

Tuesday, March 8, 2022 — Election Day.



Terms of Additional Members

§ 18A:9-11. Type II districts; terms of additional board members

The terms of the members so to be elected shall be so arranged by the members of the board holding over that as soon as possible the term of each member of the board shall be three years and the terms of three members shall expire in each year.

Legal Requirements to be a Board Member

- Be able to read and write.
- Hold U.S. citizenship and one year's residency in the district.
- Be registered to vote in the district before filing the nominating petition.
- Have no interest in, any contract with, or claim against, the board.
- Not hold office as mayor or member of the municipal governing body or simultaneously hold two elective offices.
- Not be disqualified for the conviction of certain crimes.
 (Within 30 days of election or appointment a member must undergo a criminal history background investigation through the state Department of Education.)



Nominating Petitions

A nominating petition must be signed by at least 10 persons, one of whom may be the candidate himself. Each of the signers of the petition must be a qualified voter of the school district.

Effective May 30, 2018, board of education candidates may be bracketed with other school board candidates of their choice on the election ballot. Two or more candidates may file a joint petition that may include a designation of not more than three words that conveys the principles that the candidate or candidates therein named represent. N.J.S.A. 19:60-9.

The designation shall not contain the name, or any derivative or any part thereof, as a noun or an adjective of any political party entitled to participate in a primary election. N.J.S.A. 19:60-1(b).

Brackets are counted as one ballot for drawing purposes. N.J.S.A. 19:60-8.

Tuesday, November 1, 2022 — last day to apply for a Vote by Mail Ballot via mail.

Monday, November 7, 2022 at 3:00pm — last day to apply for a Vote by Mail Ballot in person or by authorized messenger.

Tuesday, November 8, 2022 — Election Day.

Type II Board Vacancy with November Election

N.J.S.A. 18A:12-15

- In most cases a vacancy is filled by a majority vote of the remaining members of the Board after the vacancy occurs.
- Board has 65 days to fill the vacancy otherwise it will be filled by county superintendent.

If Vacancy Occurs:	Term of Member Appointed to Fill Vacancy
Before 3 rd Monday in July	Organizational meeting following the next election. Remainder of term filled at that election.
After 3 rd Monday in July	Organizational meeting following the second annual election (if the term itself extends beyond the next election). Remainder of term filled at 2 nd annual election.



Procedures to Fill Vacancy

Procedures to fill a vacancy are established by Board policy. Policy issues to be considered include:

- Advertisement of the vacancy
- Letter of interest and/or resume
- Interviews
- Deliberations
- Compliance with OPMA

Website Posting of User-Friendly Budget	4/27 to 5/11	Within 48 hours of public hearing
Deadline to Adopt Budget	By 5/14	Can adopt at or after the public hearing but by 5/14.
Certification of Amount Fixed & Determined	5/19	Certify taxes assessed, levied, and collected
Election Date	11/8

Special school election dates: 4th Tues in Jan, 2nd Tues in March, Last Tues in Sept, General Election - April or Nov (must match district's general election date), or 2nd Tues in Dec.

Type II BOE shall give county clerk and county board of elections 60 days notice in writing of its intent to hold a special election.
